Anne Margriet PotSenior Policy Advisor, WHO

Anne Margriet Pot joined the WHO in 2014 and works with both the Department of Ageing and Life Course and the Department of Mental Health and Substance Abuse. Her areas or speciality are dementia, ageing and long-term care. She contributed to the development of the World report on ageing and health and is involved in the development and evaluation of iSupport, a global e-health portal for caregivers of people with dementia.

Isabella was instrumental in the establishment of AFRAN during the period when she was Senior Research Fellow at the Oxford Institute of Population Ageing at the University of Oxford. Currently, Isabella is the Regional Chair for Africa of the International Association of Gerontology and Geriatrics (IAGG), Advisory Board member of the World Demographic and Aging Forum (WDA), Member of the World Economic Forum Global Agenda Council on Aging Societies, and Board Member of HelpAge International. She also serves on the African Commission on Human and People's Rights Working Group on the Rights of Older Persons in Africa.


Session II: Unpaid care work

Her most recent research projects have been on The Political and Social Economy of Care, and Religion, Politics and Gender Equality.

As General Secretary of the National Union of Domestic Employees (NUDE) in Trinidad and Tobago, Ms. Le Blanc represents domestic and other low-wage workers, particularly women, at the grassroots level. She also represents such individuals on issues such as wrongful dismissals, retrenchment, maternity protection violations, and violations of minimum wage requirements in courts and at the ministerial level. She coordinates worker education on existing labor legislation and develops advocacy strategies to improve the terms and conditions of contracts and reform labor legislation. Her organization's relentless lobbying has led to substantial improvements in the laws covering domestic work.

As a project and policy officer, Borja is responsible for AGE's policy advocacy and work on access to quality long-term care and the fight against elder abuse, and he coordinates the respective Task Force on Dignified Ageing. He also works on a number of European projects on long term care, integrated care and demographic change. He is responsible for project management, awareness raising among AGE members and the elaboration of policy recommendations, among other things. Borja Arrue Astrain gained experience in social policy at the European Social Observatory (OSE) and the Directorate-General for Employment, Social Affairs and Inclusion of the European Commission. Elderly care work and migration: East and Southeast Asian contexts

Ito Peng, Ph.D. is a Professor of Sociology and Public Policy, and Canada Research Chair in Global Social Policy at the Department of Sociology, and the School of Public Policy and Governance, University of Toronto. She has written extensively on family, gender and social policies, and social and political economy of care, in East Asia. She currently leads a large international partnership research project entitled Gender, Migration, and the Work of Care funded by Social Sciences and Humanities Research Council of Canada. The project brings together over 50 researchers and non-academic partners to examine how the

reorganization of care influences the global migration of care workers, and how this in turn impacts family and gender relations, gender equality, government policies, and global governance. She is a senior fellow of Asia Pacific Foundation of Canada, and a Research Associate at United Nations Research Institute for Social Development (UNRISD) and UN Women. Her new book (2017), co-edited with Sonya Michel, is called Gender, Migration and the Work of Care: A Multi-Scalar Approach to the Pacific Rim.
